As was reported on our FRONT PAGE NEWS see (www.esquireassist.com) Act 119 required the rework of the Corporation Tax procedures utilized by the Dept. of Revenue. This rework necessitated a revamp of the Corporation Tax computer system by 1-1-2008. The new system is taking longer than expected to get up and running (naturally) and until it is completed, the Department will be unable to issue lien certificates. PA - HISTORY

NATIVE AMERICANS IN PENNSYLVANIA
"Pennsylvania is unusual among eastern states in that it has no Indian reservation land. The last significant piece of Native American territory was the Cornplanter Grant, a small stretch on the west bank of the Allegheny along the New York State border. Names for the Seneca war-chief Cornplanter, the land was granted by the Pennsylvania legislature in 1791 in order to foster Cornplanter's friendship, and in 1794 Cornplanter played a critical role in securing a peace treaty with the United States."

The lands were eventually taken under eminent domain for a dam and the small remaining Seneca population was relocated.

The editors go on to state that "even Johnny Cash protested the scheme in a song that asked, "Cornplanter, can you swim?"
